#### **Digital connectivity:**

Improving essential infrastructure for business, public services and overall quality of life.









Workforce development: Attracting newcomers, retaining youth, addressing staffing shortages and ensuring a skilled workforce for the future.

#### **Growth on our own terms:**

Managing growth and increasing focus on in-province supply chains and the movement of urban dwellers to rural areas.









**Housing attainability:** Supporting the full spectrum of housing options that are affordable and attainable for all – including newcomers, young families, working people and seniors.

This was the ROMA Board's 2022 priority.



Access to services: Rural communities need innovative approaches to delivering and funding primary health care services, including bringing services to people rather than people going to services. This also includes rethinking how we maintain and fund services like long-term care and paramedicine.




