DISCUSSION ITEMS

- 7. Update on Closer to Home/ Access to Services Policy Development Kathryn Wood, CEO and President, Pivotal Momentum (*Pages 24-47*)
 - Kathy Woods presented the proposed recommendations for the Improved Access to Services for Rural
 Ontario. Emphasis is placed on the importance of the recommendations section, specifically addressing
 the challenges faced by rural Ontario in healthcare.

Other highlights included are:

- The situational analysis section contains results from surveys, data from various sources, historical reports, and interviews with subject matter experts.
- The report highlights the lack of attention to rural Ontario in mandate letters and aims to demonstrate the unique challenges faced by the region.
- Recent developments, such as the pilot project with school bus stop cameras and reports on healthcare issues in rural areas, are discussed.
- Emphasis on the need for rural leaders' active engagement in Ontario health teams to bring about positive changes.
- Recommendations focus on making a breakthrough in public policy initiatives that differentially benefit rural Ontario.
- The report acknowledges a long-term challenge in addressing the shortage of primary care physicians.

- The importance of nurse practitioners and a bridging strategy is mentioned to address healthcare issues in the short term.
- Strategies to reduce demand on emergency rooms and build community services are proposed.
- The report suggests integrating social determinants of health into healthcare system structures.
- Dedicated funding for community-focused innovation and addressing impending changes in public health Ontario are highlighted.

An Executive Summary of the report and a backgrounder will be provided for distribution once complete.

Lindsay Jones gave updates on the trains and drains issue. Key dates and communication strategies were shared.

Lindsay provided an update on the Ministry of Health's process for voluntary mergers across local public health boards. Issues reviewed included: the voluntary nature of the mergers, no extra costs for municipalities, reinvestment of savings, maintaining service levels, flexible population targets, realistic plans, addressing representation concerns, recognizing Indigenous representation, and avoiding increased administrative burdens.

Daniela Spagnuolo shared AMO's advocacy on access to health services in Ontario

The Board received an update on AMO's advocacy regarding gender-based violence. Recent activities were including: the Ministry of Children, Community, and Social Services announcement on an integrated gender-based violence prevention strategy that is responsive to and aligns with AMO's advocacy. A concurrent session featuring speakers and ongoing work into 2024, including research and member education initiatives, will be held at the ROMA conference.
