6. 11:00 am Conference Update – Victoria Van Veen

Victoria Van Veen reviewed the following on the ROMA Conference:

- Registration update 510 registrations to date compared to 210 at the same time in 2018. Exhibitors are also being confirmed with a total of 40 at the time of discussion. Traditionally 58 exhibitors are on display with this number or higher anticipated for 2020.
- Political Presence invitations to Ministers have been extended, the Board discussed delegations to Ministers and will work with staff to confirm best approach and issues to bring forward.
- Program update session development is well under way with most speakers confirmed. The Board discussed an interest in a number of areas including diversity and equity, climate change and conservation authorities
- Board member accommodations and contributions and contributions to prize draws
 Board members were asked to confirm accommodations as well as were invited to donate to the prize draw. Board Roles and Responsibilities will be reviewed on site Saturday or Sunday of the Conference.

POLICY

7. Policy Update – Cathie Brown

Cathie Brown, Senior AMO Advisor reviewed the following policy issues with the Board:

- The Provincial Fall Economic Statement was reviewed including the stating provincial fiscal forecast. The Board was advised that discussions on rural economic development will occur at the upcoming ROMA conference.
- Bill 132 (Omnibus bill): a number of policy issues were reviewed including the move to
 Administrative Monetary Penalties, introduction of the Aggregates and repeal of the Line
 Fences Acts as well as changes to many matters dealing with agriculture, agricultural
 organizations, food, medicines, and the Nutrient Management Act and removing matters
 associated with motor vehicles out of the Environmental Protection Act, matters dealing
 with mining and northern service boards.
- Waste Management Update: AMO staff have been conducting a number of workshops
 across the province advising Municipal governments who operate blue box programs on
 the need to prepare for the transition to full producer responsibility and that Councils
 will need to make a number of key decisions in the next year on the transition process
 for their program. AMO staff will continue to work with the Municipal Resource Recovery
 and Research Collaborative (M3RC) to develop and communicate advice to municipal
 governments through the transition process.

Additional Discussion Items:

- The Board discussed bio security concerns including the importance of rural communities having tools to manage and address trespassing.
- A number of questions were raised regarding the pilot on escooters. Staff will keep the Board apprised as the matter evolves.
- Support for the reintroduction of photo radar in community safety zones was raised. Similar to bio security matters, rural communities need tools to deal with safety issues in their communities.
- The Board inquired into process regarding ROMA Pengagement on health review.
