5. Creation of New Zone 9 & Zone 10

The Board reviewed the briefing note and discussed the issues and implications of a zone change, including the need for a broader discussion on Zone configuration. Given the immediate request from municipalities in Northwestern Ontario, the Board agreed to proceed with the creation of a new Zone 10 at this time, followed by a broader review of Zone configuration in time for the 2023 Zone elections. Other matters considered included the process for ratifying the decision and for electing a representative for the newly created Zone 10, and the importance of maintaining the current Zone 9 representative for the remaining term of the Board.

The Zone 9 representative, Bill Vrebosch, left the room and did not participate in the discussion pertaining to Zone representation.

"That the Board approve the creation of a new Zone 9 and Zone 10 to replace the current Zone 9.

That the Board undertake a comprehensive review of Zones in advance of the 2023 Zone elections.

That the new Zone 9 includes the City of Greater Sudbury and municipalities in the districts of Algoma, Cochrane, Manitoulin, Nippissing, Parry Sound, and Timiskaming, and that the new Zone 10 includes municipalities in the districts of Kenora, Rainy River, and Thunder Bay, including the City of Thunder Bay.

That a General Special Meeting be arranged to coincide with the 2019 AMO Conference for the purpose of ratifying the Board decision to create a new Zone 9 and Zone 10 and that appropriate notice be provided.

That, following ratification of the Board's decision to create a new Zone 9 and Zone 10 at a Special General Meeting in August 2019, notice be given for an election in Zone 10, to be conducted at the ROMA 2020 AGM and Conference; and

That the current, elected Zone 9 representative continue to represent Zone 9 until the end of the current term of the Board."

The Board discussed matters relating to ROMA zone election and recognized that this issue had potential implications for other organizations and that consultation would be appropriate.

The Board discussed resolutions urging ROMA to meet with OGRA to discuss the possibility of consolidating the ROMA and OGRA Conference, which have been separate since 2017.

The Board had a lengthy and considered discussion about the history of the ROMA-OGRA relationship. The discussion included the circumstances which led to the creation of separate conferences in 2017, the distinct mandates of the two organizations, and the importance of the conference to ROMA's ability to fulfill its responsibilities toward rural municipalities. The Board also discussed the importance of ensuring that ROMA is communicating effectively with its stakeholders and the municipalities it serves.

The Board expressed an interest in meeting with OGRA to learn more about its proposal and its goals. One idea that was explored was the possibility of having the conferences sequentially with a view to reducing the costs of attendees who are interested in both rural municipal and roads issues.

The Board directed that the matter be addressed in the next ROMA Newsletter to provide readers with a better understating of the issues.
