12. Update on Provincial Housing Consultation at ROMA Conference – Robin Jones, ROMA Chair/Monika Turner, AMO, Director of Policy

Monika Turner provided an overview of the Premier's affordable housing consultation scheduled for January 23, 2022. The consultation would include representatives from FONOM, NOMA, OSUM and the EOWC. The AMO policy team will be scheduling a prebriefing with the ROMA Board and other attendees prior to the Premier's consultation.

13. ROMA Post-Secondary Award Update – Adam Garcia, Program Coordinator & Advisor

Adam Garcia advised the Board signed agreements for ROMA's three-year scholarship fund of \$15,000 annually with the University of Guelph and Trent University have been finalized and that the agreement with Lakehead University is in process.

Amber Crawford provided a high-level overview of the following policy matters:

- That the Ministry of Infrastructure released a Statement of Intent, published Building Broadband Faster Act Guidelines, and launched a reverse auction (The Accelerated High-Speed Internet Program)
- That Minister Thompson (OMAFRA) is in the process of drafting a letter to CN Rail in accordance with the meeting had with the ROMA Board in November 2021
- The Excess Soil regulations come into effect on January 1, 2022 and encourage Councils to attend one of the December webinars scheduled
- That the Conservation Authorities Act Phase I Regulations were finalized as of October 2021, and Councils are encouraged to work with CAs on the transition plan (due December 31, 2021) and the inventory (due February 28, 2022)
- There are new Planning Act delegations for staff that were introduced in Schedule 19 of the Bill 13 Supporting People and Businesses Act, 2021.
- The Long-Term Care Act changes received Royal Assent on December 7, 2021.
