- 11. Policy Update Amber Crawford, Senior Policy Advisor, AMO
  - i. National Adaptation Strategy

Canada's First NAS was announced on May 13, 2022, which requires a completion date of July 15<sup>th</sup> for the online survey which Amber will provide. All orders of government will have an opportunity to unite through the following:

- Public Engagement (Spring/Summer)
- Final Strategy Development (Late Summer/Fall)
- Release of NAS (End of 2022)
- ii. Federal Flood Hazard Identification Mapping Program

The Blue Box regulation was passed in June 2021, with an amendment in April. Contract terms were published for those who wish to receive blue box collection. The deadline for municipal councils to decide whether they wish to participate is July 15, 2022. A webinar will be held on June 22, 2002 in conjunction with Conservation Ontario to discuss CA Phase II Regulations

iii. Housing

Bill 109 - passed on April 14<sup>th</sup>, ERO comments were due April 29. AMO is working post-writ with MMAH to send out additional information. A site plan control delegation by-law is required by July 1, 2002 and will apply by January 1, 2023, which no longer allows bump up provisions to Council Rental Housing Strategy – AMO staff working to develop one alongside Housing and Planning Forces and non-profit providers and are seeking input along with endorsement with new government.
