9. Review of Spring Meeting Itinerary – Petra Wolfbeiss, Director, Membership Centre, AMO (Pages 57)

Petra Wolfbeiss reviewed the itinerary of the Offsite Spring Board Meeting with the board members. The itinerary includes a tour of Base 31, a decommissioned WWII air training base that has been transformed into a community and arts hub. A community partnership bought the 70-acre site to create a mixed-use development with living art installations and an events space. This partnership brings together a broad array of local experts from affordable housing, and commercial and retail to infrastructure and adapting heritage sites.

The rest of the itinerary includes meeting with the Thrive PEC team, a briefing with the representatives of the Prince Edward County Affordable Housing Corporation, and a social gathering with the Mayor and Council of PEC.

- iii. Codes of Conduct for Municipal Councillors Bill 5 defeated in legislature, key messages to members advising mobilization at the local level.
- iv. MTO consultation on Off-Road Vehicles MTO is consulting on changing the rules for ORVs including raising age limits for drivers and passengers in responding to the recommendations of two inquests.
- v. Ministry of Public and Business Services Delivery consultation on Locates MPBSD and the Ministry of Energy are consulting on changes to the Ontario Underground Infrastructure Notification System Act to ensure locates are provided without charge and to make the system for locate requests and delivery more efficient.
