Peter Emon and Meredith Staveley-Watson presented the Eastern Ontario Wardens' Caucus (EOWC) "7 in 7" regional housing plan to address the shortage of affordable rental housing. This multi-year strategy includes a number of proposed funding strategy across the public, private and other options. The Board is generally supportive of the plan and requested a further discussion be scheduled with the Board once the strategies are more concrete.
