### 7. Policy Briefing

#### i. Update on Policy Centre Priorities - Alicia Neufeld, Policy Senior Manager, AMO (*To be delivered*)

The Policy Centre provided an update on current initiatives, noting that they continue to monitor recent funding announcements, including the Ontario Community Infrastructure Fund (OCIF), the Federal Build Canada Homes (BCH) program, the Road Safety Initiatives Fund (RSIF), and ongoing oversight of HART Hub funding.

Staff also reported continued collaboration with Indigenous partners on the implementation of AMO's Indigenous Reconciliation Action Plan, which aims to provide a roadmap for local governments in supporting economic development, infrastructure needs, social priorities, and strengthened relationships

with First Nations, Inuit, and Métis communities.

In addition, the Policy Centre is turning its attention to the ROMA 2026 Conference, preparing mainstage and concurrent sessions that reflect and advance ROMA's key objectives and rural concerns.

ii. Rural Infrastructure Strategy (Pages 28-40)

The ROMA Board endorsed moving ahead on a rural infrastructure advocacy strategy. This strategy will guide policy and advocacy efforts, provide the Board with a consistent and compelling narrative on rural infrastructure needs, and renew calls for the AMO socio-economic and prosperity review. Staff noted that this work will be supported by a survey to be distributed to members to gather broader insights into municipal asset management plans.

The ROMA Board endorsed AMO staff's plan to develop a Rural Health Strategy informed by the findings of AMO's Health Survey, which highlighted significant municipal contributions to public health, ambulance services, and long-term care in 2024. The discussion emphasized the importance of community engagement and data-driven analysis to support effective strategic advocacy.

iv. School Closure Moratorium Proactive Advocacy (Pages 56-67)

The ROMA Board endorsed a strategic approach aimed at lifting the province-wide moratorium on school closures to better protect schools in rural communities. Given the disproportionate impact of closures in these areas, the strategy will focus on key priority issues to guide advocacy on this matter.

The ROMA Board received an update on registration, exhibitor participation, sponsorship and mainstage programming for the 2026 Conference. With 747 delegate registrations and 43% of exhibitor booths sold, early indicators were positive.

Programming including mainstage and concurrent sessions were reviewed and discussed.

Also reviewed were options for the Sunday lunch, with agreement to explore joint Zone meet-ups held over a plated lunch to help increase participation and address the concern with space and offering Sunday lunch.

Options and recommendations for the renewal and expansion of the ROMA Post-Secondary Awards for the five year period beginning in 2027 were tabled. Key decision points included:

- Continuing to provide the ROMA Award to Trent University and the University of Guelph (with increased opportunities to profile the award);
- Discontinuing providing the bursary to Lakehead University
- Establishing an award with Nipissing University;
- Expanding the program to include four recipients, including a partnership with the Ontario Municipal Administrators Association to support its bursary program.
- Expanding the funding contribution over 5 years from \$75,000.00 to \$100,000.00
